(The meeting was called to order at 6:09 p.m.)

MAYOR GANIM: Not only do we have a quorum, it looks like we have a full – a full complement of members.

All right. If there is no – it seems like looking around – I've just kind of looked and kind of informally gotten nods from everyone that people seem to be ready to go. It seems like we have not only a quorum, but a full complement of board members; all the technical people are here; the microphones seem to be working. Members of the public and press seem to be here. We have two members – two members of the City Council; the city clerk's here; one of the members of the city attorney's office is here; members of the public are here. Let me just say good evening.

And there's a printed agenda, which is rather short, but just let me formally say we are opening now the first – or the annual organizational meeting of the Board of Education, being held this day, Monday, December 9th, 2019, at 6:00 p.m. It is approximately 6:00 p.m. We are at the Bridgeport Regional Aquaculture, Science and Technology Education Center.

And there's a brief agenda; there's four items on that. And I'm going to take them in the order that they are – and I'll just read all four and then we'll go to the first one. They are election of officers; then they are, number two is approval of 2018 organizational meeting minutes; three is approval of calendar year 2020 schedule for regular public meetings; and four is to adjourn.

MR. SOKOLOVIC: Mr. Mayor. I'm sorry - I'm sorry to interrupt, I

would like to make a motion to table something because it's going to 2 require some discussion -

> MAYOR GANIM: All right. Well, I'm going to proceed with the election of officers, and we'll go from there. Okay.

MR. WELDON: Mr. Mayor, if I may.

MAYOR GANIM: Yeah.

MR. WELDON: I've had the privilege of serving this board as chairman for the last two years. In that time I'm proud to say that I've had the ability to lead the board and move it forward in many ways.

I've served in this role at a time when the board faced operational challenges, many of which have been addressed and corrected under my leadership. By way of example, a program of yearly workshops covering areas such as the Freedom of Information Act, Robert's Rules of Order, and development of board goals and objectives has been instituted. This has allowed the board to develop its own professional ways not seen in years.

Additionally, last year, for the first time in ten or fifteen years, the board conducted a performance review of its superintendent as required by law, which was reflective of the honest, individual views of each board member.

Also, previously strained relationships with our collective bargaining units, the teachers' and administrators' unions, have been repaired to the point where we've now started to work together with them in a more collaborative fashion.

In addition, earlier this year, board bylaws which hindered effective

board operation were completely overhauled, resulting in board policy and procedure being so clearly defined that parties who formerly manipulated them were no longer able to do so, and ultimately became so frustrated that they threw up their hands and left, which opened the door for other people who truly care about serving Bridgeport Public Schools to take their place. And that's a good thing.

Last, as a result of these initiatives, our meetings no longer last three to four hours. Instead, over the past year our work has been made to become focused to the point where we're able to hear from the public, receive committee and staff reports, and transact our actionable business efficiently in no more than ninety minutes. This allows the public we serve to be able to observe the workings of the board in a reasonable time frame that allows them to do so without sacrificing other areas of their lives.

My more vocal detractors have accused me of being a maniacal, power-hungry, gavel-wielding dictator. In reality, I've simply been a strong chairman serving at a time when the board needed one to help put it on a path of stability and progress, and I feel that I've achieved that as evidenced by the examples I've just given.

Having said all of this, I'd like to make a nomination of our current Vice Chair Jessica Martinez to serve as our chair for the upcoming year. Jessica has expressed her interest in this role, and given the successes I've just described as having had in it, I'd like her to have the opportunity to shine her light and make her own imprint on the workings of this board.

| 14 | nomination of Jessica Martinez and a second. Now I'm going to ask if |
| 15 | there's any nominations. We're going to go through the nominating |
| 16 | process of the chairman or the president of the board first, and then the |
| 17 | next. |
| 18 | If you'd like to second the nomination or nominate someone else, |
| 19 | you know, anybody can have the floor and I'll recognize anybody for a |
| 20 | nomination. |
| 21 | MS. BROWN: I don't have a nomination, but just a clarification, I |
| 22 | guess, if I can put it. |
| 23 | MAYOR GANIM: Sure, on the voting? |
| 24 | MS. BROWN: Oh, not on voting. |
| 25 | MAYOR GANIM: Okay. So we're going to vote - what we're going |

to do is we're going to go through, do the nominations and the votes, and if there's any questions on that I'll try to clarify. And then I'm either going to stay or any other points of matter people want to bring up can be brought up at that time. But right now we're doing the nomination of the officers.

Do you want to make a nomination?

MR. SOKOLOVIC: Yes.

MAYOR GANIM: Okay.

MR. SOKOLOVIC: I've been a member of this board for two years; I've got a 97 percent attendance rate. I've pushed – my committees have pushed through almost every issue that's come before this board for action. Since the last two years of chair we have lost a lot.

To my left, where Ms. Brown and Ms. Benejan – Mr. Benejan – are sitting, there used to be students there. They used to be able to give reports to their school. Through those super new bylaws those students are now gone.

I am very reluctant – I have nothing against Ms. Martinez, I think she's a wonderful person. I think she's definitely for the children, but as a paid charter school lobbyist, I think it's very dangerous to have a paid charter school lobbyist as the chairperson of Bridgeport Board of Education, a public school. Because when you advocate for charter school dollars, you take only from one pool of tax dollars, and that's the tax dollars.

Every dollar that goes to a charter school is one dollar less that goes to Bridgeport Public Schools, and for that reason I'm going to

And we have – we have a lot of goals; we have a lot of plans; we have a lot of things to accomplish together. And we've started already and much to do.

| 22 | MS. MARTINEZ: Do you want to discuss? |

| 13 | the regular and add it to the regular meeting agenda because there's a |
| 14 | couple – there's a couple problems with the schedule. |
| 15 | MS. MARTINEZ: Do you want to have a deeper discussion? |
| 16 | MR. SOKOLOVIC: It requires some discussion, yes. |

| 15 | spring break; there's two other dates with special meetings which need |
| 16 | some discussion whether we want to have special meetings where the |
| 17 | public don't speak or move them to Tuesdays. I guess that might be little |
| 18 | involved. |
| 19 | MS. MARTINEZ: Yes, sir. |
| 20 | MR. ILLINGWORTH: I – I don't have a problem discussing it now. |
| 21 | My only concern is I don't - you know, we will need a two-thirds |
| 22 | requirement to add it to the regular agenda. I don't know if those - I |
| 23 | mean, I don't know if those votes are - are here to go to add that to the |
| 24 | agenda. So I don't know if you want to take that risk and not discuss it |
| 25 | here, because – |

| 8 | MS. MARTINEZ: Okay, let's discuss. What are the dates in |
| 9 | question that you are concerned about? |
| 10 | MR. SOKOLOVIC: The first date would be Monday, April 13th, |
| 11 | which is the first Monday of spring break. Students and staff will all be |
| 12 | on vacation; myself and possibly everybody else would like to take a |
| 13 | break. So that date right there is no good. |
| 14 | And then you've got two other dates – Monday, May 25th, |
| 15 | Memorial Day, it says no meeting, a special meeting may be called on |
| 16 | another date. |
| 17 | Now, the problem with a special meeting is the public needs a |
| 18 | chance to speak. We've got twenty meetings a year. To cut them out of |
| 19 | these next two meetings without a chance to speak and voice their |
| 20 | opinion, I don't think is fair to the public. I think it would be preferable to |
| 21 | move these two Monday dates to the following – the Tuesday following, |
| 22 | just to give the public an adequate chance to speak, and for us to do |
| 23 | business. |
| 24 | MS. MARTINEZ: John. |
| 25 | MR. WELDON: The purpose of our regular meetings is not to |

| 10 | MR. SOKOLOVIC: Since I've been on the board – since I've been |
| 11 | on the board, the Monday meetings on holidays have always followed on |
| 12 | the following Tuesday with the regular meeting scheduled, last year |
| 13 | included. This special meeting stuff has just started in the last year. |
| 14 | MR. WELDON: And that doesn't mean that that was the right way |
| 15 | to handle it. Okay. |
| 16 | MR. SOKOLOVIC: Well, you handled it before. |
| 17 | MR. WELDON: Stop. |
| 18 | MR. SOKOLOVIC: No stop. The chair stops it, not you. |
| 19 | MS. MARTINEZ: Okay. Do you have something to say, Hernan? |
| 20 | MR. ILLINGWORTH: Yeah, just a point – a point of clarification. |
| 21 | So the – the first date that is in question is the first – is the Monday that |
| 22 | happens to be on the first day of spring break? |
| 23 | MR. SOKOLOVIC: Correct, that's April 13th. |
| 24 | MR. ILLINGWORTH: All right. Now - |
| 25 | MR. SOKOLOVIC: And we could reschedule that - |

MR. ILLINGWORTH: Now, usually – yes. Usually, I mean, I – I think that could be a typo or an error that someone possibly missed, because that – normally we do always because staff and everyone is entitled to a break, and that's why we definitely don't have meetings that week.

The other meeting, yes, it's – you are correct, if it falls on a holiday we normally do Tuesday. It doesn't mean we have to. So, you know, we could just do one – one meeting that month, and if we need an additional meeting we could always do a special meeting. And remember, we could always suspend the rules and allow public comments as well, so if the chair sees fit – as along we add it to the agenda, I don't see a problem with it.

MR. SOKOLOVIC: Yes. Yeah, as far as the spring break, I'm not comfortable not having – we've got twenty meetings, two per month during the school year. And I'm not comfortable in a school system with 20,000 children, 2700 employees, with there not being enough information to hold a meeting. I mean, we've got always something to do. If anything, there could be updates from the superintendent; if anything, there's public speaking.

I was elected to listen to the public. I want to know what the public thinks about the issue in a timely fashion before I get to vote. I would like to know the public – the public – I mean, if we're not here to listen to the public, what are we doing here? What are we doing here if we're not here to listen to the public? A special meeting in our bylaws does not require public speaking, but a regular meeting requires the public

| l | speaking. By voting for a special meeting we're taking away our right |

| 3 | MS. MARTINEZ: So, Joe, what do you propose? |
| 4 | MR. SOKOLOVIC: I propose just making those two - moving the |
| 5 | spring break because that's not the public speaking thing – to maybe the |

| 7 | meeting, but we could also the Tuesday thing if we look into it - and |
| 8 | then the two Monday meetings, just hold them on Tuesdays like we've |

| 21 | see Tuesday, May 26th, for a regular meeting rather than a special |
| 22 | meeting; and Tuesday, October 13th, for a regular meeting rather than a |
| 23 | special meeting. |
| 24 | MR. TESTANI: So the 6th will conflict with the City Council if |
| 25 | everyone's okay with that Just an EYL |

| 14 | MS. MARTINEZ: Any opposed? Any abstentions? Motion carries. |
| 15 | Thank you. |
| 16 | Okay. The last item on the agenda is to adjourn this meeting. |
| 17 | ATTY. ANASTASI: Madam Chair, I don't mean to interrupt, but I |
| 18 | think you just amended the schedule. You should probably now vote to |
| 19 | adopt the schedule as amended. |
| 20 | MS. MARTINEZ: Vote on the main motion? Okay. |
| 21 | MR. SOKOLOVIC: Thank you. |
| 22 | MS. MARTINEZ: Oh, I take that back. Is there a motion to approve |
